FACILITY USE TERMS AND CONDITIONS

The following terms and conditions apply if Vendor is using the facilities of Grand Canyon University facilities in accordance with this application.

1. The sale, possession or use of alcoholic beverages is prohibited without prior written approval of the Grand Canyon University Foundation and Grand Canyon Education, Inc.
2. Concession rights (if any) are retained by Grand Canyon University Foundation unless stated otherwise in this agreement.
3. No structure is to be altered without written permission of Grand Canyon University Foundation's designee. When such changes are allowed, the property must be restored to original condition at my expense. All extra properties are to be removed immediately following the event/ performance.
4. Indemnity: Vendor agrees to completely indemnify Grand Canyon University Foundation and Grand Canyon Education, Inc. and to protect and save harmless Grand Canyon University Foundation and Grand Canyon Education, Inc. from and against all claims, actions and suits, whether groundless or otherwise, and from and against any and all liabilities, losses, damages, judgements, costs, penalties, taxes, assessments, charges, attorney's fees and other expenses of every nature and character which Vendor suffers or incurs or to which it may be subject or for which it may be liable. If Grand Canyon University Foundation and Grand Canyon Education, Inc., in its sole discretion, pays any amounts by reason of any of the matters described above, Vendor shall reimburse Grand Canyon University Foundation and Grand Canyon Education, Inc. within fifteen (15) days of notice of such payments. If Vendor does not reimburse Grand Canyon University Foundation and Grand Canyon Education, Inc. within fifteen (15) days of such notice, Vendor will reimburse Grand Canyon University Foundation and Grand Canyon Education, Inc. for such payments together with interest thereon at the rate of 12% per annum from the date of the payment of any such amount.
5. Grand Canyon University Foundation reserves the right to refund any advance deposits and cancel this event should Grand Canyon University Foundation decide that the function/use is not in the best interest of the Grand Canyon University Foundation and Grand Canyon Education, Inc.
6. Vendor must cover itself, the Grand Canyon University Foundation, and Grand Canyon Education, Inc. with insurance coverage, the limits of which shall be \$1,000,000/\$3,000,000 for bodily injury/ property damage liability as well as automobile liability covering any owned, non-owned, borrowed, leased, or hired autos with a limit of \$1,000,000 combined single limit per accident. This coverage will also include a waiver of subrogation clause in favor of Grand Canyon University Foundation and Grand Canyon Education, Inc. A certificate of insurance providing evidence of required coverage limits, and naming Grand Canyon University Foundation and Grand Canyon Education, Inc. as an additional insured must be submitted in advance of use.
7. Vendor agrees to provide all required certificates of insurance to Grand Canyon University Foundation together with the signed Agreement. In no event shall certificates of insurance be delivered to Grand Canyon University Foundation later than forty-eight (48) hours prior to the start of the Event. Failure to do so shall constitute a breach of this Agreement and Grand Canyon Education, Inc. shall charge you an additional \$1,000.
8. All fees for usage are due on the day of the Event unless other arrangements are agreed to by Grand Canyon University Foundation in writing.
9. Vendor's representative scheduling use of the facility must be 18 years of age or older and must be in attendance throughout the scheduled time. An Authorized representative for a requesting group shall sign the rental form and the signature shall be considered acknowledging and agreeing to the policies and regulations in regard to the use of the facility on behalf of the group.
11. All trash is to be placed in the trash containers prior to exiting the facility.
12. Vendor shall not be allowed access to the facilities prior to their scheduled time and must clean up and vacate the premises no later than the indicated time on the contract.
13. Events shall be confined to the specific part of the facility assigned to Vendor.
14. Failure to comply with any of the stated policies may result in the forfeiture of Vendor's right to utilize the facilities of Grand Canyon University in the future.
15. Vendor understands that all information provided will be used with the intent of participating in the 2017 Run to Fight Children's Cancer event.
16. No refunds will be issued for those who fail to attend the event.
